## TRAINING COURSE "WHERE INNOVATION MEETS TRADITION"

The subject of the training course is the use of STEM tools in youth work related to topics of ecology and agriculture. Participants will have the opportunity to explore STEM perspectives from different industries and learn how to implement them in their youth work. They will have the opportunity to learn to design their own stem lessons for young people, visit local areas where agriculture takes place using STEM tools.

## The **specific objectives** of the project are:

- Improved knowledge about STEM and innovations in industry
- Improved knowledge on various STEM activities for young people
- Improved knowledge on agriculture and farming technologies
- Enhanced ability to design AgroSTEM curriculum/lesson and implement it in practice
- Improved ability to motivate and engage students in AgroSTEM learning
- Working on case studies and guidelines
- Learning about STEM lesson connected to farming, agriculture, ecology
- Knowledge about basic farming technologies and practices
- Knowledge about digital tools to use in STEM lessons
- Knowledge about traditional farming problems and how to solve it
- Intercultural awareness of the participants and their sense of a common European identity;
- Knowledge of Erasmus+ program and Youthpass certificate.

### **TRAVEL**

Travel expenses of the participants are covered in line with Erasmus+ Programme rules and European distance calculator.

Please keep **originals of the travel tickets and boarding passes**, as without such documents we will not be able to make the reimbursement.

**Reimbursement** of travel expenses for the participants will be carried out through bank transfers (to the account of sending organization / group leader) after the main activity, upon collecting all relevant documentation.

The costs will be reimbursed ONLY if you take part in ALL of the activities foreseen within the project.

# **⚠ IMPORTANT**

This project fully implements a practice of **GREEN TRAVEL**, in line with priorities set within Erasmus+ Programme guide for 2021. – 2027. Green travel is defined as **the travel that uses low-emissions means of transport for the main part of the travel**, such as bus or train

Therefore, participants should travel either by BUS, TRAIN or CAR POOLING.

Distance should be calculated by using the European **Distance Calculator** (<a href="https://ec.europa.eu/programmes/erasmus-plus/resources/distance-calculator\_en">https://ec.europa.eu/programmes/erasmus-plus/resources/distance-calculator\_en</a>) for each of the participants individually.

We kindly ask all of the participants to calculate their travel distance in advance (prior to buying tickets), as in case if they fall within lower travel distance (e.g. between 100 and 499 km) their travel limit is lower.

Please consult us before buying any tickets!

# **⚠ IMPORTANT**

It is important to obtain travel insurance for the full duration of the project, including travel days.

## COVID-19 RELATED EXPENSES

Before making travel arrangements and departing to the project venue, please make sure to check the current COVID-19 related measures necessary to cross the border. If needed, each participant has to arrange individually their process of obtaining:

- certificate of vaccination, or
- certificate showing that you have recovered from COVID-19 and have received one dose of vaccine, or
- negative COVID-19 test to enter Croatia as well as to return back to their sending country.

COVID-19 tests can be reimbursed **up to 200 EUR per participant** (maximum full amount, not per test >> if the participant needs to obtain 2 negative tests for the departure and return, the overall amount that can be reimbursed is 200 EUR) in accordance with the approved project budget.

# **⚠** IMPORTANT **⚠**

If the participants are staying after the project (based on their own arrangement), the organizer will not be able to arrange their departure COVID-19 test.



## SAFETY & RISK-PREVENTION

## **IMPORTANT**

In order to protect themselves and others, it is necessary that participants pay attention to the prescribed safety measures:

- Everyone should wear a mask in public settings, especially when other social distancing measures are difficult to maintain;
- In closed spaces it is recommended to wear a mask and maintain physical distance;
- In open spaces it is necessary to maintain the required physical distance;
- It is necessary to cover mouth and nose with a tissue when coughing or sneezing;
- It is necessary to wash hands often after being in a public place, or after blowing your nose, coughing, or sneezing.

The host will take all necessary preventive measures in accordance with the current epidemiological situation caused by the COVID-19 virus.



## VENUE

# PELJEŠAC, OREBIĆ - BORJE



**Orebić** is a port town and municipality in the Dubrovnik-Neretva county in Croatia. It is located on the Pelješac peninsula on the Dalmatian coast. Orebić is directly across a strait from the town of **Korčula**, located on the island of the same name. Ferries service the two towns frequently. Orebić is 112 km (70 mi) from Dubrovnik.

When it comes to things to do in Orebić, the main attractions of this town are the famous Trstenica Beach, the Maritime Museum, the Franciscan Monastery of Our Lady of Angels, Captain's Cemetery and Mount St. Elijah (Sveti Ilija).

There is something else that makes Orebić special and that is a scenic view of the mountains rising above the sea. The town is located at the foot of **Mount Saint Elijah**, which is 961 meters high. Legend says that the summit was once called Perunovo Brdo (Perun's Mountain), after the name of the old Slavic god Perun, the master of thunders.

If you come to the Pelješac Peninsula by land, the first thing you'll see is **the medieval town of Ston** and its impressive fortifications which are called the "Great Wall of Europe". An interesting fact is that they are the longest defensive walls in Europe and the second-longest in the world, after the Great Wall of China.

You need to try local food: fish brodet, dried figs, oysters, quality wine, macaroni cake, fritters or croquettes.



## **HOW TO REACH OREBIĆ?**

If you are traveling by airplane, the closest airports are Split airport (169 km) and Dubrovnik airport (113 km). From Split or Dubrovnik airport, it is necessary first to take a shuttle bus to Split / Dubrovnik main bus station.

From bus stations in Split in Dubrovnik there are direct bus lines to Orebić.

A member of our staff will pick you up at the bus station in **Orebić** and take you by car to your final destination (project venue) in **Borje**.

## DON'T FORGET TO BRING!

- Personal medication;
- Identification documents (ID, passport, visa, etc.);
- Health/travel insurance;

- Warm and light clothes (climate is changing in May, through day is usually 20 degrees, but at night it can be around 10 degrees); clothes for outdoor activities; workshop clothes.

## INTERCULTURAL AND LINGUISTIC PREPARATION

Croatia (kroʊˈeɪʃə/ kroh-ay-shə; Croatian: Hrvatska [xřvaːtskaː]), officially the Republic of Croatia (Croatian: Republika Hrvatska), is a sovereign state between Central Europe, Southeast Europe, and the Mediterranean.

Its capital city is Zagreb, which forms one of the country's primary subdivisions, along with its twenty counties. Croatia covers 56,594 square kilometers (21,851 square miles) and has diverse, mostly continental and Mediterranean climates. Croatia's Adriatic Sea coast contains more than a thousand islands.

The country's population is 3.87 million. The official language is Croatian.

## **YOUTHPASS**

Youthpass is a tool to document and recognise learning outcomes from youth work activities. It is available for projects funded by Erasmus+: Youth in Action (2014-2020) and Youth in Action (2007-2013) programmes. It is a part of the European Commission's strategy that supports the reflection upon the personal non-formal learning process and outcomes.

While creating their Youthpass certificate together with a support person, project participants are given the possibility to describe what they have done in their project and which competences they have acquired. The certificate can be helpful in obtaining jobs and improving career progress since it can easily be attached to one's CV and serve as a proof of professional development.

## **8 Key competences for Lifelong Learning** evaluated by Youthpass are:

- a. Communication in the mother tongue
- **b.** Communication in foreign languages
- c. Mathematical competence and basic competences in science and technology
- **d.** Digital competence
- e. Learning to learn
